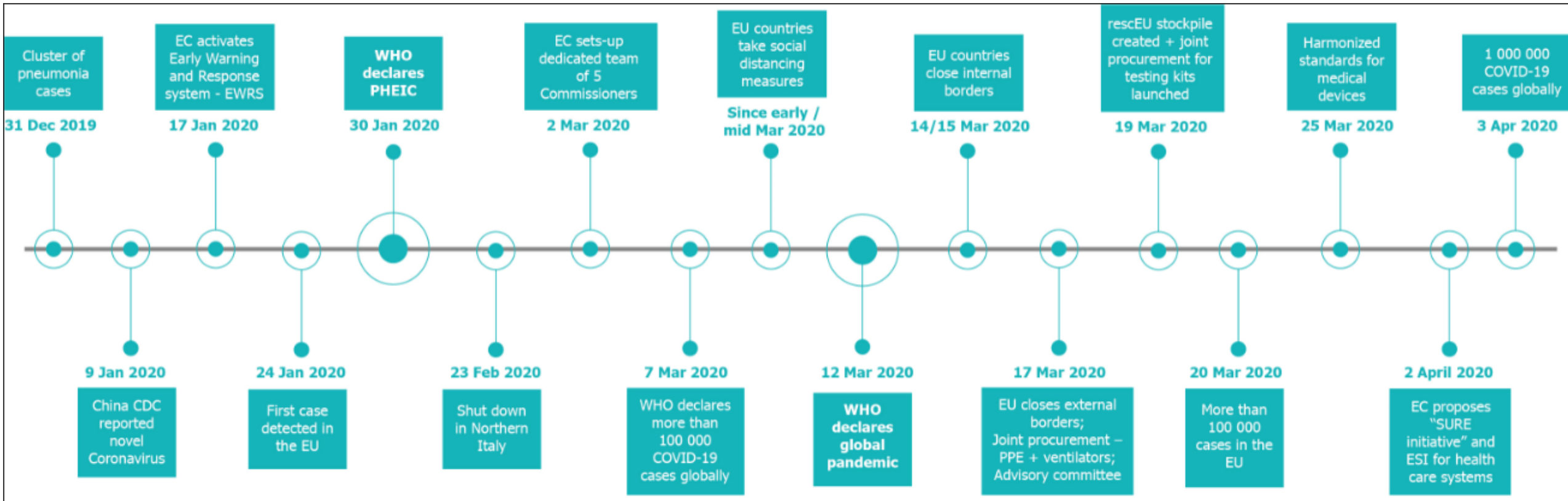

# EU health security framework – Decision 1082/2013/EU

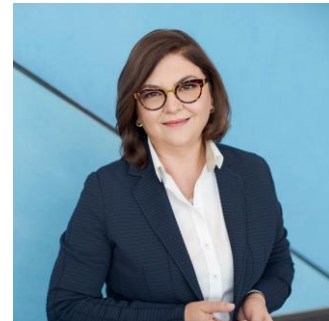
- Preparedness framework (regular reporting)
- The Early Warning and Response System: member states/commission exchange info on alerts and measures
- Health Security Committee
  - Responsible for coordination of measures
  - Health Security Committee's Communicators' network.
- Joint procurement

# The Health Security Committee

- coordinates public health preparedness and response to the outbreak – 12 meetings so far on COVID-19
- discusses: epidemiological situation, risk assessment, capacities (public health and health care, laboratories, medical countermeasures), response measures and recommendations
- New: sub-network on clinical management
- EU role is to complement and support and to assist with EU policies and actions e.g. joint procurement

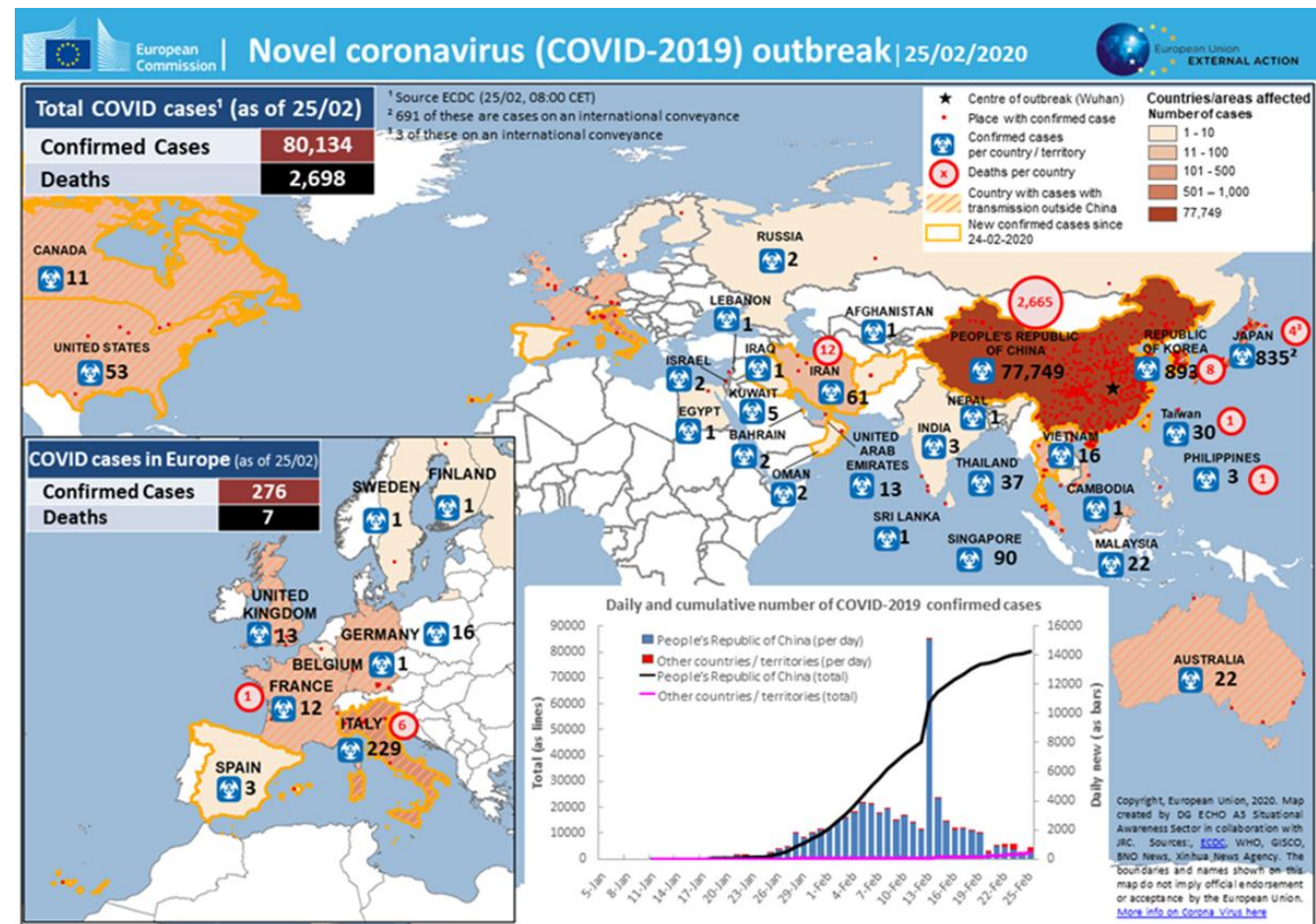

# Early European response

- Activation of EU/Member State/Agencies Integrated Political Crisis Response – European Council – EU Presidency
- Commission’s Emergency Response Coordination Centre monitoring the outbreak
- Member States reporting cases: EWRS
- EU Civil Protection Mechanism: repatriation of citizens from China, Iran, cruise-ships



# Measures by the Commission

- The Commission set out a European coordinated response to counter the economic impact of the COVID-19 outbreak (13 March).
  - Corona Response Investment Initiative
- Guidelines to Member States for health-related border management measures (16 March)
- European team of scientific experts to strengthen EU coordination and medical response (17 March)
- Three extraordinary Health Ministers Council meetings have been convened so far

# Ramping up production of personal protective equipment (PPE)

- EC assesses:
  - available stock of PPE
  - production capacity
  - anticipated needs
- Discussion: industry to convert production lines
- Exports of PPE outside EU ➡ export authorization by MS





# Joint procurements

Launch of 4 joint procurements of PPE with Member States:

- 28 February: a call for PPE
- 17 March:
  - face masks, gloves, goggles, face-shields, surgical masks, overalls
  - ventilators
- 19 March: a call for testing kits
- Offers received – contracts in the making
- New: EU's RescEU stockpile of medical equipment – building – up



# Border and mobility

Bone-marrow,  
organs for  
transplantation,  
blood and  
tissues...

- Temporary restriction on non-essential travel to the EU (30 days)
- Guidelines on 'green lanes': speedy and continuous flow of goods across the EU important for supplies of pharma
- Guidance: support air cargo operations during the coronavirus crisis

# Promoting research

- €48.5 million for 18 projects by 140 research teams
  - Improving epidemiology and public health
  - Rapid point-of-care diagnostic tests
  - New treatment and vaccine development
- IMI call - up to €45 million from HORIZON2020 – same amount from industry
- CureVac: up to €80 million EIB loan - launch clinical testing of a vaccine by June 2020

# Shortages of medicines

- Solidarity between MS is crucial: ensure patients most at need receive treatment
- Close monitoring the supply of medicines with EMA and national authorities
- Weekly EU Executive Steering Group on shortages
- Regular calls with the EU pharmaceutical industry
- Guidelines and Q&As at EU-level

# Clinical Management Support System

- a web conferencing support system for the clinical management of COVID19 patients.
- Based on existing IT structure for European Reference Networks for rare diseases



- Clinicians consult other clinicians in Europe on the more complex cases, exchange information and diagnosis

# Using every available euro in every way possible to protect lives and livelihoods

- new EU solidarity instrument - €100 billion - to help workers keep their income & businesses retain staff.
- ESIF - fully flexible – every € directed to
  - support public health efforts or
  - cushion the economic blow for people and businesses.
- use all available € from 2020 EU budget help respond needs of European health systems
  - €2.7 billion - Emergency Support Instrument,
  - €300 million – rescEU stockpile

## Snapshots of European Solidarity



France has donated 1 million masks to Italy and Germany has donated 7 tons of masks and other protective equipment, helping save lives.



Tens of thousands of European citizens have been repatriated from abroad, with most flights being intra-European.



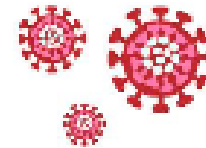
# Three specific groups in the EU Health Policy Platform
